With reference to above, the validity of above mentioned Selling Agency Agreement for disposal of scrap, rejected/ condemned/ obsolete materials un-serviceable plant & machinery, surplus stores/ spares etc. is hereby extended for a period of 02(two) years from 01.04.17 to 31.03.2019 on the same terms and conditions on negotiated/nomination basis.i.e The service charge shall be payable @ 1.8% plus service tax (extra) as applicable at the time of disposal which is same as per the last extension.

M/s. MSTC Ltd will make sure that all the data security features as per advice of Central Vigilance Commission, Govt. of India and also as confirmed vide letter No. MSTC(D)/SAA/SECL/16-17/24384 dt. 04.03.2017 remains throughout the validity period of the contract.

M/s.MSTC shall abide by all rules, regulations and guidelines of Indian IT Act, 2000, duly amended.

In the extended contract, MSTC shall neither sublet the job nor engage any agent in the contract.

The proposed extended contract with M/s MSTC shall be subject to the provisions of the Mechanism of Permanent Machinery of Arbitrators (PMA) in terms of Office Memorandum No 4 (1) 2011-DPE (PMA)-GL dt 12.06.2013 issued by RakeshBhartiya, Joint Secretary to the Government of India, DPE.

If CIL finalizes the contract for e-auction of scrap material ,the same shall be adopted in SECL immediately.


