**ADDENDUM**

This has reference to the Notice No. CIL/C-4B/TPA/2021/23 dated 10.5.2021, served to all Consumers of Coal, regarding empanelment of Third Party Agencies by CIL for sampling & analysis of Coal.

At the end of the comparative table, it was mentioned, "The consumers are hereby requested to engage the Third Party Agencies as per their choice".

However, following provisions have already been provided in case of Non-regulated Sectors (**Non-power FSAs**) for road dispatches.

1. Schedule V- Existing & LOA Route FSAs [Refer clause 5.2.3 (i) &(ii)]
2. Annexure – VIII - NRS linkage Auction FSAs[Refer clause 5.2.3 (i) &(ii)]

1.2 – Third Party Agency for dispatches by Road

1.2.1 - QUOTE

"In case of off-take of the contracted grade of coal via road mode, the seller shall choose third party agency to conduct the third party sampling from a list of independent third parties provided by CIL from time to time. It is clarified that the Seller shall have the sole discretion and right to replace, substitute or change the third party sampling agency chosen by it"

UNQUOTE

In case of road dispatches for non-power consumers, one gross sample is prepared for all consumers who opted third party sampling taking coal from a source covering supplies for a day.

In view of above, the foot note of the Table in the Notice No. CIL/C-4B/TPA/2021/23 dated 10.5.2021, may be read as modified below.


Earlier Foot Note

"The consumers are hereby requested to engage the Third Party Agencies as per their choice "

Amended Foot Note

"The Power utilities may engage a Third Party Agency of their choice for all modes of supplies out of agencies empaneled by seller from time to time. However, Non- Power consumers (NRS) may engage the Third Party Agency of their choice in case of supplies by mode other than Road and in case of Road supplies, the Third Party Agency will be decided by the Seller".
